

## June 13<sup>th</sup> Meeting - 7:30 pm Clark House


Located at **6332 Barcroft Mews Drive** in Falls Church, the Clark House may be reached by taking the Beltway Exit east on Little River Turnpike, 2 miles to a left on John Marr Drive. Make a right onto Columbia Pike. Go 1.8 miles and turn right onto the service road at Barcroft Plaza (Harris Teeter is one of the stores). Turn left on the service road and proceed to the Barcroft Mews Townhomes adjacent to Barcroft Plaza. Clark House is on the left as you enter the Barcroft Mews Townhomes. The house is a three story yellow Victorian. Turn at the bus stop enclosure. By that time, you can see Clark House straight ahead. Overflow parking will be in the strip mall next door.

Coming from Bailey's Crossroads: West on Columbia Pike. Go through light at Braddock Road. Take the FIRST left (protected turn lane) and make an immediate left to townhouses. (If you pass the traffic lights at Linconia and Columbia Pike, you've gone too far).

Patrick O'Neill is about to enter his 20<sup>th</sup> year in archaeology in August. He has a BS in Anthropology from Kansas State University and an MA in History from West Texas A&M University. The National Park Service excavated the site and has now reconstructed the fort into its glorious splendor. ## "Lost" Document Found! By C.K. Gailey

Researchers working on the Battle of New Market, May 15, 1864, have had a serious problem. There has been no copy of the official report of Union casualties in the battle. The casualty reports for most Civil War battles were published a century ago in the Official Records, but it contains no report for New Market. The best anyone could do was a report in a New York newspaper which was generally known for accurate reporting but which was not official.

I got lucky. In delving through the files on New Market in the National Archives, I found reference to a report a Dr. Hayes made about the battle. Dr. Hayes turns out to have been Gen. Sigel's command surgeon. General Sigel was commander of Federal forces at the battle; this document was the official report of Union casualties. It is a wonderfully complete record, listing the dead, wounded, captured and missing by name and regiment. It gives details of many of the wounds received in the battle. It even bears annotations made after the summary was submitted, noting some soldiers who were reported killed but who were not dead.

Using this report, as well as other documents in the Archives and elsewhere, Patricia Gallagher and I were able to put together as complete a list of Union killed at the Battle of New Market as has ever been assembled. Copies of Dr. Hayes' report and our supplement have been placed at the New Market State Historical Park and other places likely to be searched by those interested in this battle.

**Turtle Hill (44FX2636)** - Laura James, a senior from Mercyhurst College in Erie, Pa., has joined County Archeology for a summer internship. She will be supervising deep excavation testing of the site. Current plans are to begin with a bank cut profile in the gully on the eastern edge of the site and to complete the two 5x5-foot test pits currently open. That will be followed by additional test pits and/or a test trench.

Theoretically, since the site is on an alluvial fan jutting out into the South Branch floodplain, it is possible that various sedimentary outwash events may have buried ancient landforms. It is these that we hope to discover, because they may have remains from very early occupations. We will probably be working three days a week (including Saturday) in the field throughout June and July.

**David Site (44FX2634)** - The first C-14 dates from the site have been returned from BETA Analytic and, according to Paul, they couldn't be better. It seems that the elongated triangular points date to between A.D. 650 and A.D. 820, which is where they should have dated. Another date of ca. 1380 B.C. may be associated with the numerous soapstone bowl fragments recovered from the site. Several more carbon samples are being processed by BETA. They include residue from pottery, which should directly date the pottery types. All of the lab work is done. Paul and Berno are doing the analysis for the report.
