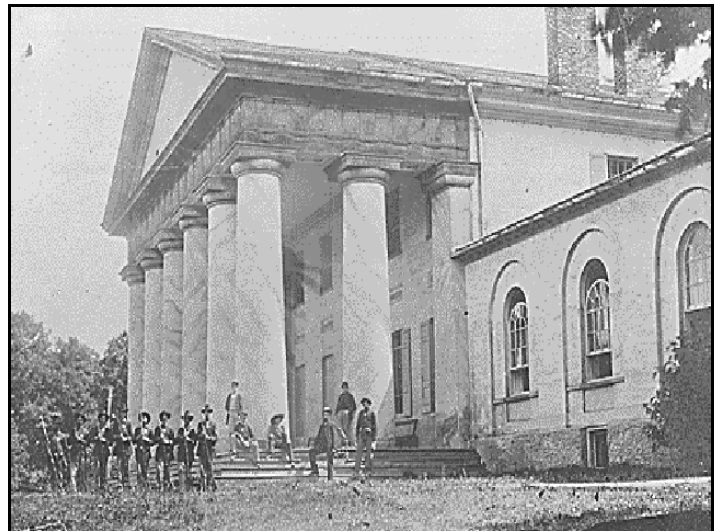

## April Talk

## Archaeological Investigations at the Arlington House

Patrick O'Neill has a BS in Anthropology from Kansas State University and an MA in History from West Texas A&M University. He has been doing archaeology for over 20 years in as many states for almost as many CRM firms. Currently, Patrick is employed as a Principal Investigator for the Louis Berger Group in Washington, DC.

Berger conducted field investigations for the National Park Service at the Arlington House (44AR17) in November and December 2003. The mansion and two dependencies/slave quarters were constructed by George Washington's step-grandson George Washington Parke Custis between 1804 and 1817. Robert E. Lee married Custis' only surviving child, but only lived in the house a few years prior to the Civil War. The Army assumed control in the 1860s and the NPS in the 1920s. The investigations recovered information on pre-construction land surfaces under the dependencies, original floor levels, courtyard landscaping events, and a dry well used as part of a dairy located inside the south wing of the main house.

### **2004 Germanna Historical Legacy Lecture Series**

The 2004 Germanna Historical Legacy Lecture Series on Thursday nights in April (April 1, 8, 15, 22 and 29), at 7 to 8:30 in Rm 114 of the Locust Grove Campus of Germanna Community College, there will be a series of free lectures sponsored by the Germanna History Club.

#### The lectures will be:

- **April 1:** Prof. Rob Sherwood: a virtual tour of the 15 most important historic sites at and in the vicinity of the Locust Grove Campus.
- **April 8:** Dr. Douglas Sanford: the archeological survey and excavation between 1986 and 1992 at the site of Governor Spotswood's "Enchanted Castle" site.
- **April 15:** Dr. Rich Gossweiler: entrenchments at Germanna Ford and their role in the Civil War campaigns of Fredericksburg, Chancellorsville, Mine Run and the Wilderness.
- **April 22:** Thomas Faircloth: the history and accomplishments of the two German immigrant colonies at Germanna.
- **April 29:** Donald Tharpe: the first Germanna colony into what is now southern Fauquier County and his archeological survey at the Tillman Weaver House (1721).
- **Saturday, April 17:** a walking tour of the 15 most important historic sites around Locust Grove Campus.

## **Proposed Dog Park at Fort Ethan Allen By Mary Green**

I want to let you know about a big sore point in Arlington Historic Preservation circles. A dog park in the middle of the Civil War Fort Ethan Allen. On Tuesday night there was a public forum of the Fort Ethan Allen Canine Area Relocation Task Force at the Lubber Run Community Center. There are some members of the Task Force who are pushing to keep the dog park at its present location in Fort Ethan Allen. However, I think that is clearly a minority sentiment within the Task Force. There are several alternative sites under consideration I think will make good locations for the dog park, but I expect that there will be complaints about every alternative.

Public sentiment should be that the status quo is the least acceptable alternative. Each person had two minutes to speak. There were over 100 people there and 43 signed up to speak. I talked about how we needed to take care of our Civil War heritage and move the dog park to another location. The Task Force had identified 19 sites and requested comments. Two minutes each. This is the "Arlington Way." Next the Task Force will make a recommendation to the County Board. This discussion has been going on for a couple of years. The County is actually in violation of its own rules by having a dog park in a historic area.

### **CULTURAL RESOURCE PROTECTION SECTION**

In recognition of **National Volunteer Week**, the Fairfax County Park Authority is sponsoring a fun event at Lake Accotink Park on Saturday, April 17, from 9:30 to 12:30. Many activities, including enjoying the amenities of the Park before they open for the season, are planned for Park Authority volunteers and their families. Keep an eye out for this; there will probably be an RSVP.

Master plans for Union Mills and Ox Hill Battlefield started this month. A public task force was formed in order to involve professionals and knowledgeable citizens with forming concepts for the development of the parks. This is the first attempt to expand the GMP process to more than one park with the same historic theme. Perhaps this is the beginning of regional GMPs for the Park Authority. Draft plans for Woodglenn Lake Park and Nottoway Park were completed.

**LAND BAY A** - CRPS has begun the final push to recover data from this unplowed prehistoric site. The first phase involves re-doing the shovel test pattern, because the first attempt by the consultant overlooked data (fire cracked

rocks, most pottery, and exotic raw materials) critical to locating habitation and processing areas on the site.

The first re-do of a transect, last year, led to discovery of a stone platform hearth, quartz crystal component (possibly Clovis) and an extremely rare, jasper, Jacks Reef Pentagonal component. The first re-testing this year located a second area producing green metavolcanic flakes, which are a very rare lithic stone type in Northern Virginia.

Once done with the shovel testing, CRPS will intensively recover any potentially significant cultural areas within the site. This is a very significant upland site that was not adequately assessed and dealt with during Phase II and III work paid for by the developer last year. The developer has informed CRPS he plans to begin construction in June. As a result, we will need as much volunteer help as possible. Our plans are to work Monday through Friday and whenever possible on Saturdays.

**LAUREL HILL GOLF COURSE DATA RECOVERY - CRPS** is currently monitoring construction on the new Laurel Hill Golf Course on the old Lorton Prison site. To date we have found one new historic site, verified one previously recorded prehistoric site, and found eleven new prehistoric sites. Associated points from the prehistoric sites have included Palmer (Early Archaic), probable Savannah River (Late Archaic) and Calvert (Late Archaic). The historic site consists of an unidentified brick patio-like feature. Monitoring depends on when areas are stripped of vegetation and have been rained upon sufficiently to expose artifacts.

#### **NOTTOWAY RIVER PALEOAMERICAN SURVEY -**

We have completed most of the auger testing on our first test area. The testing was first designed to reconstruct the geology of the Nottoway River floodplain in the study area. Although some knowledge has been gained, conclusions await more detailed soil analysis of the soil samples recovered from selective tests. We have located three buried prehistoric site in the process and will be test excavating two of them soon after the soil analysis has been written up.

**MAACs -** On Friday March 12, 2004, archaeologists from the **Cultural Resource Protection Section** of the Fairfax County Park Authority participated in a symposium at the Middle Atlantic Archaeological Conference (MAAC) entitled "Archaeology in Fairfax County Virginia: Recent Contributions" organized and chaired by Liz Crowell. Participants in the symposium included permanent employees Liz Crowell, Mike Johnson, John Rutherford and Richard Sacchi; exempt employees, Jan Sutton and Berno Tops; former exempt employees, Nancy Anthony and Paul Inashima; former intern, Laura James; and

archaeological consultants representing Thunderbird Archaeological Associates, John Milner and Associates, Parsons, and Hayes and Monaghan. Papers presented in the symposium reported on prehistoric and historical archaeological projects that have been conducted in Fairfax County both on parkland and done as part of development review. The symposium was well-received. Liz Crowell is incoming Recording Secretary for MAAC and serves as the Chairman of the Awards Committee. This year she served as one of the judges in the student paper competition.

**Duties include:** Monitoring backhoe excavation during removal of fill materials, shoveling and troweling to identify locations of grave shafts and previously disturbed areas, clearing brush, hand excavation of archaeological units, and recording archaeological discoveries. Work involves considerable physical activity.

**While not restricted to the following, some of the minimum requirements for this job include completion of certification classes, at least two months of supervised field and/or laboratory training, as a student in an archaeological field school, or as a volunteer with a professional archaeological organization.** Applicant must be in good physical condition and able to work outdoors.
