## May 13th Meeting - 7:30 pm Clark House

Located at **6332 Barcroft Mews Drive** in Falls Church, take the Beltway Exit east on Little River Turnpike 2 miles to a left on John Marr Drive. Make a right onto Columbia Pike, go 1.8 miles and turn right onto the service road at Barcroft Plaza (by a Harris Teeters). Turn left on the service road and proceed to the Barcroft Mews Townhomes adjacent to the plaza. Clark House is a three story yellow house on the left as you enter the town homes. **Turn at the bus stop enclosure.** Overflow parking in the Plaza.

**Coming from Bailey's Crossroads:** West on Columbia Pike. Go through light at Braddock Road. Take the **FIRST** left (protected turn lane) and make an immediate left to townhomes.

## **Stratified Prehistoric Sites along the C&O Canal By Dr. Stuart Fiedel**



Dr. Fiedel is a Senior Archaeologist with the Louis Berger Group in Washington, DC. Fiedel received his Ph.D. from the University of Pennsylvania and specializes in prehistoric archeology of the Northeast and Mid-Atlantic regions. He is the author of *Prehistory of the Americas* (1987) and several articles on Paleoindian chronology, Pleistocene extinctions, Early Woodland climate change, blood residue analysis, and Algonquian migrations. Dr. Fiedel has also worked in Spain, France, and Turkey and has been recognized as a Fellow of the New York State Archaeological Association.

Geoarchaeological "prospecting," using a predictive model has resulted in discovery of deeply stratified, multi-component prehistoric sites on Potomac River floodplains in the C&O Canal National Historical Park. Occupation zones sealed by alluvial deposits include Late Woodland, Terminal Archaic Broadspear, and Early Woodland components. Fiedel will explore both the culture-historical significance and resource management implications of this ongoing research.

## CULTURAL RESOURCE PROTECTION SECTION GROUP

April was a busy month. Mt. Air is currently going under a \$97,000 restoration of the brickwork remaining from the fire. Other items include creating interpretive areas and filling in the cellar hole after clean-up. The 20<sup>th</sup> century garage will be demolished and the 20<sup>th</sup> century well house will also be pulled down. The well house has been measured drawn and photographed. Fire damage was so severe nothing could save this 20<sup>th</sup> century outbuilding. It is slated to be replaced. **Monies are from the last bond – so vote for the next one this November.**

Other bond funds have brought us the archaeology done at Union Mills, a treatment plan for Union mills both yet to be completed. Additional bond funds were used at Huntley for archaeology associated with the architectural construction of the original building and material culture overtime.

Working on reports of previous archaeology completed at Huntley Historic site. This includes the excavation of an outbuilding that is the mirror image of the storage/root cellar structure. No function for the structure was determined through the artifact database or structural components. It likely served as storage and was not the long sought after kitchen.

The Marker for the Manassas Gap Railroad Historic Site came in and will be placed by the abutment on the Cub Run Stream Valley trail. A view shed will be made and the abutment cleaned up and interpreted. This was done in cooperation with the History Commission Marker Committee.

John Rutherford received the RMD Stewardship award for his work with GIS and archaeology. May will be a very

busy month as we are moving to our new renovated facility at James Lee Center. More on that next month.

**Land Bay A (44FX2723)** - As we continue to deal with finishing up aspects of the site, which were not completed by the consultant, we have discovered additional Culpeper ware pottery concentrations. Interestingly, Berno and the crew's testing, when coupled with the re-do of the shovel test sample, indicates that the pottery may have been associated with a special activity area. They have recovered a very low amount of stone debitage with the pottery but have found a moderate quantity of fire cracked rocks. Approximately, 50-75 feet away, the shovel test sample has revealed an area rich in stone debitage (quartz, quartzite, rhyolite, and pitted hornfels) but lacking in pottery concentrations (so far). Before we move on to the stone debitage area, the crew will explore the exposed sub-soil for features. Hopefully, datable features from the Culpeper ware time period can be detected and dated. So far the ware has not been dated. We are looking at mid-June to finish the phase III data recovery. **Anyone interested in helping is urged to call the Elmore lab (703-787-3778). Fieldwork is six days a week (M-Sat) and lab is held concurrently on Tuesdays.**

### ASV Board Meeting by George Monken

The Quarterly ASV Board Meeting was held 1 May 2004 at Kittiewan Plantation. The following are highlights of the meeting. Mike Barber reported that the Field School would be held 12-31 July at Keyser Farms. The major goal of this year's field school will be to tie in the recent excavations with excavations done in 1939. Randy Turner reported on DHR status. The happy news is that the State Budget for DHR should be at the same level as last year. Proposal for Threaten Sites are due NOW. DHR has developed a Resource Kit for use in teaching about African American archeology sits. The kits may be borrowed from any of the Regional DHR offices.

Several comments were made expressing concern about the quality of previous presentations and "last minute" preparation by some chapters.
