## From the Veep – C.K. Gailey

Many thanks to Stuart Fiedel for his talk last month. For those of you who missed it, Stu presented preliminary results from the first 3-year phase of the survey of the C&O Canal. He told us about sites which have deeply stratified deposits and multiple buried A-horizons, ranging from Paleo/Early Archaic to Late Woodland. He finished with a discussion of possible causes for the depopulation of the Potomac Piedmont before 1600 (Was it climate, including a Little Ice Age and two major droughts? Was it warfare between tribes? Epidemics?)

It's really happening! The Elmore Farm lab is really moving back to James Lee. The Lewinsville lab has already moved, as has Liz Crowell. The move for Elmore Farm will be June 16 and 17. Needless to say, a whole lot of packing has to happen.

## **VDHR state burial permit regulations and procedures**

VDHR is forming a committee currently holding meetings concerning some re-writing of the state burial permit regulations and procedures. Specifically, the issues are (1) whether or not to curate some of the remains excavated (under a VDHR permit) from gravesites for future types of testing such as DNA or isotope sampling; and (2) whether human remains should be displayed publicly or used to illustrate publications circulated to the general public (e.g., National Geographic, etc.). The committee includes a wide variety of people, including a bio-ethnicist, a representative of the Virginia Council of Indians, Dr. Doug Owsley, Dr. Barbara Heath (chair, representing COVA)--and Martha Williams (Williams is considered as the ASV representative). The first meeting was this last week--intended largely to present the issues and generalized discussion. Two other meetings will follow.
