Projects and Future Plans

Speaker – Kay McCarron

Dr. Kay McCarron is currently the Executive Director of the John Singleton Mosby Museum and Education Center. Dr. McCarron received her BA degree in history and political science from Agnes Scott College in Decatur, Georgia. She received her MA in Anthropology and her Ph.D. in Education from the University of Virginia. Dr. McCarron has been a professional archaeologist for the past 30 years and has worked in the fields of archaeology, historic preservation and museum studies in the Colorado Preservation Office, the Charleston Museum, the Manassas Museum and the Fairfax County Heritage Resources Branch.

Dr. McCarron is currently researching the women who lived at Brentmoor: The Spilman-Mosby House in the last half of the nineteenth century. In addition, she is developing educational programming through partnerships with the Mosby Heritage Area, the Warrenton Antiquarian Society and the Afro-American Historical Society of Fauquier County. Dr. McCarron is a member of the Council of Virginia Archaeologists, the Archeological Society of Virginia, the Virginia Association of Museums, the Society for Historical Archaeology, the Fauquier County Historical Society and the International Society for Technology in Education. She serves on the Advisory Boards of Weston, The Warrenton Antiquarian Society historic site, and the Historic Preservation Certificate Program of the Northern Virginia Community College, Loudoun Campus.

RIVERBEND, FROM A VOLUNTEER’S POINT OF
VIEW

Mike Johnson is conducting a survey a Riverbend County Park property and is using volunteers to help get the area covered. The site is a very nice one and the time of year is super for working in the field. Lots of trees and varying

terrain make the prowling very interesting, and it's coupled with weather meaning comfort while walking the ground and a bit too cold for the bugs to be out in force. Also, the new low growth hasn't come in, so it's easy to walk in the woods. It's a nice area to wander and a nice time of year to be in the field.

The parkland borders on the Potomac, so people have been in the area for a long time. The result: prehistoric and historic sites. This also allows for discussion of where or why the people of a given time period might have occupied a site. This has ranged from talk of rock raw material sources for prehistoric folk, to historic quarry operations in the area, and whether an area that has a lot of rusted metal might have been the site of an illegal whiskey still. Also, a point has been found each day we have been out. This is a very good omen and incentive for persons interested in prehistoric folk. Interesting observations on the plants in the area have been made ranging from what the local flora are to the identification of areas with foreign plants and trees. There are a lot of vestigial roads and paths in the region adding complexity to trying to interpret the past.

Surveys are fun because there is no drudge work in the field. We are on the move and looking for prizes and, when the mood strikes, you can do a STP just to make sure that what is on the surface is representative of the area. There is a lot of freedom to explore what you think might be fruitful under the overall mandate of surveying thoroughly.

An important factor for volunteers is always lunch. Riverbend offers some very nice sites for lunch eating. This includes areas with lovely views of the Potomac and sheltered areas that are comfortable and promote discussion of the area and archaeology in general. Also, there are whitetail deer, some very healthy and colorful cardinals, and various other critters to see as you drive in and out of the area. All in all, the Riverbend survey is a great way to start the field year.

RIVERBEND PARK SURVEY

During April, Park Authority Archeology staff and volunteers started work on a reconnaissance level survey of Fairfax County's Riverbend Park along the Potomac River above Great Falls National Park. Field sessions start at the Park Visitor's Center on Tuesdays at 9:30 a.m., where the crew meets before heading off to the day's survey area. Currently, the crew is working in the southern end of the park. The plan is to proceed northward along the Potomac until the Park is completely surveyed.

The process involves a thorough pedestrian reconnaissance in which all areas of the Park are walked. Any observed exposed ground is carefully inspected and selectively trowel scraped. Since the Park is largely forest covered eroded uplands, potential stratigraphic sites are confined to the floodplains and the bases of slopes. Selected areas are also subjected to selective shovel/trowel testing. All artifacts are recorded and left in the field.

Three days of surveying were completed in April. They resulted in 12 new prehistoric and historic archeological sites being discovered. To the pleasure of everyone one prehistoric stone point has been found each day. They include two quartz Selby Bay-like points, one apparently being a drill bit, and one rhyolite Piscataway point base discovered in a shovel test by Gene Silva. All appear to date to the Middle Woodland (ca. 500 BC-AD 500).

Historic finds include an apparent 19th century stone quarry, possibly associate with the Great Falls aqueduct. Several more recent historic occupations were found on the quarry floor. One of those occupations appears to be a 1960s fishing park visited by volunteer Scott Silsby when he was a teenager.
