
At our March meeting, we were pleased to elect the father-son team of Wilke and Will Nelson to fill our vacant vice presidency.

David Thulman

Paleoindian issues in Florida



Thulman's dissertation at Florida State University explored how the first people in Florida organized themselves in an uninhabited landscape by testing alternative hypotheses of Paleoindian social organization in Florida during the post-Clovis, Middle and Late Paleoindian periods (ca. 10,900 – 10,000 BP) through analysis of artifact typology and distribution and the application of anthropological theories of band-level social and subsistence structure. He collected images and location information of Paleoindian points from Florida, measuring and analyzing them for the purpose of producing a typology. The location information was entered on a GIS

FAIRFAX COUNTY ARCHAEOLOGY

Cardinal Glen (44FX3379) - As of this writing the crew has completed excavating the A soil. The site continues to produce moderate amounts of quartz artifacts and fire cracked rocks. It has produced a surprisingly low number of diagnostics. To date we have recovered one possible sand tempered potsherd and a fragment of a corner notched quartz point. During preliminary deep testing of the initial trench, we encountered the top of what appeared to be post mold. As a result of the possible post mold feature the threatened parts of the site will be deep excavated. The work schedule on Cardinal Glen will be determined by the work schedule on Clarks Branch.

Clarks Branch (44FX3226) - Detailed excavations on expanding Square 1 will begin as soon as the federal permitting process is complete. That should be in early April. Once that happens Paul will be working full time on the site and will need all of the help he can get to finish the data recovery so the bridge construction can be accomplished before winter.

GIFT IN MEMORY OF PAT FULLER

Our Northern Virginia Chapter has received a generous gift from Hal Fuller in memory of his wife Pat, our chapter member, friend, and recent Vice-President. In making the gift, Hal said, "The work of the chapter and the friendships of its members were central components of Pat's life. I thank you all for the friendship that you

gave her and for the support that you have given me in coping with her illness and death."

After discussion among officers, staff, and members, the chapter decided to use the gift to substantially enlarge the Dave Rubis Research Fund. This fund is used very selectively, with chapter approval required, to support scientific research and testing in cases where other funding is unavailable. Members expressed their appreciation and said they thought Pat would have liked the decision. A letter of thanks to Hal said, "We in the chapter are pleased to honor Pat by putting your gift to use in this important way, knowing that she participated in the decisions to do this scientific work when she was among us."

Pat Fuller and Dave Rubis would have been part of the same crew on those occasions when Pat dug at Cactus Hill. Pat also dug at Gunston Hall and other local sites, was a regular in the lab, and participated in the chapter in many ways. She became a Certified Archaeological Technician in 2003.

FORMER CHAPTER MEMBER, BOB HEUSER

It was nice to receive the following report from Bob Heuser, one of five members of the Northern Virginia Chapter who graduated from the certification program in 2003. From Ann Wood

Every time I get and read an issue of the Datum Point I say I have to write ... I have remained a member of No. Va. chapter since we moved to CO three years ago so I can keep up with what's going on there. I have become a member of the Denver chapter of the CAS (Co Arch Soc) and have participated in some field survey, excavation, and lab activities. This past year I was asked to be on the Board of the Denver chapter (must be no one else was interested). One of the responsibilities is to write an article a year for the monthly newsletter, so I wrote my first one on archaeology at Gunston Hall.

I am really glad I finished the certification program in VA; that has given me some measure of credibility when I'm asked about my experience. CO also has a program that is quite different from VA's. It includes 13 20-hour courses with an exam at the end of each course which must be passed to receive credit. There are 4 or 5 different types of certificates, each requiring different courses. Since rock art is big out here, I took the rock art course (one night a week for 7 weeks) and somehow passed it. But, I don't think I'll go for any certificates. I really enjoyed the VA program with it's hands on approach, even though we did have to take a final exam (can't believe that was 5 years ago)!

Another difference out here is that there is no year-round program of excavation etc., like at Gunston Hall and Fairfax County. I miss my weekly days at Gunston and the occasional lab or field survey at Fairfax Co. (in spite of the lyme disease) and am really thankful that I had the opportunity to go to Cactus Hill! Weather here is GREAT... no humidity. We're busy in a variety of activities, including work trips to New Orleans for post Katrina relief (me 4 times and Chris 2 times), many activities through our church, and of course taking care of our now-3 year old granddaughter, who will be getting a baby sister in January (more infant care on the horizon). If your travels bring you this way let us know... we love to see "old" friends from back East.
