## JANUARY'S SPEAKER, PATRICK O'NEILL

### BATTLE OF THE WHITE HOUSE, THE ONLY WAR OF 1812 BATTLE IN FAIRFAX COUNTY



The British burned Washington on August 24, 1814, and intended to march down the Potomac under protection from their own ships. The Potomac Squadron, as the ship convoy was called, was late and the British went back the way they came. However, the Potomac Squadron did cause the destruction of Fort Washington on August 27<sup>th</sup>, and held Alexandria Virginia hostage from August 28-September 1<sup>st</sup>.

To "annoy and destroy" the Squadron on their descent, US Commodore John Rodgers, Captains David Porter and Oliver Perry brought 500 seamen and, with 1500 Virginia Militia under Brigadier General John Hungerford, they engaged the British for 5 days at the White House on Belvoir Neck in sight of Mount Vernon. The presentation will also include a display of artifacts from the battle!

Patrick O'Neill has a B.S. in Anthropology and a M.A. in History. For over 25 years, he has traveled across the United States and conducted archaeology and historical research projects in over 32 states. ## FAIRFAX COUNTY ARCHEOLOGICAL COLLECTIONS

Over the last 30 years Fairfax County Archeology has become the repository for most archeological collections recovered in the County. For many years the collection was split between the Heritage Resource Management Program in the Office of Comprehensive Planning (now Department of Planning and Zoning) and the Cultural Resource Protection program in the Park Authority. With the move back to the renovated James Lee Center the two County programs were physically merged.

As the consolidated program's Collections Manager, Bob Wharton spent several years merging the two artifact collections, which had been kept under separate indexing systems. This was a major undertaking, especially since he was dealing with a County-wide collection that included approximately 3 million items and a Park collection that involved several hundred thousand items.

He eventually completed the task. However, to everyone's surprise that process filled up the brand new storage space including all of the additional shelf space gained by installing brand new "compactor shelving" in the renovated basement ("Dungeon" as it is fondly called). When Bob (and Gail) left the County to take care of Grandchildren, parents and go fishing, etc., that left the critical Collections Manager position vacant. Liz Crowell was able to convince the Park Authority that the collection was important enough to re-fill Bob's position.

Aimee Wells was selected for that position. However, her position has been slated for deletion at the end of this physical year. As a result the long term management of the collection is a serious question. In the interim between Bob's departure and Aimee's hiring the office began a project designed to "compress" the collections in order to increase shelf space and buy time. That process has resulted in compressing all of the collections from 1980 through 2000, which has opened enough shelf space for more than 200 boxes.

Some 25 saved box spaces (more than 10%) has been due to a planned de-accessioning of the Lowes Island artifacts to Loudoun County. Also a large number of massive soil and flotation samples from earlier projects were processed and/or discarded, if appropriate. The largest gain was made when Bob installed a whole new bank of shelves along a previously open wall and the pre-2000 collections involving several thousand

boxes have been moved. As that process has progressed we have discovered errors and backlogged cataloguing.

As a result, much of the lab work over the last couple of months has been on sites dating to as early as the late 1980s. Many of the lab work will be on very interesting material. As we begin the New Year the County Archeology Program will continue to try to get the collection up to the best possible condition so it hopefully can withstand as long as possible a loss of dedicated management oversight.
