### <u>CHANGES TO ANNUAL DUES</u> By John Kelsey

As I've written before, the Chapter is reverting to membership on a calendar year basis for 2012 and beyond. Dues themselves are not being raised. When your current membership expires, you will be asked to renew through the end of 2011. The dues for 2011 are prorated as shown below depending upon your expiration date to account for the fact that most memberships run into 2011. Those of you with expiration dates in October, November, or December of 2011 will not need to renew this year – your memberships will carry over until the end of the year.

Family memberships will be the cost of an individual membership plus \$2. For example, my family membership for 2011, based on an August expiration date, will be \$7. Student renewals will continue to be \$5 for the year.

For future years -2012 and beyond - annual dues will be payable on January 1<sup>st</sup> and must be paid by March 1<sup>st</sup> to avoid disenrollment.

I initially thought to email a list of expiration dates to the rest of you, but did not do so because I was concerned about sending this information out to everyone. #### **COLCHESTER UPDATE**

**By Colchester Archaeological Research Team** It has been a cold month for the Colchester Archaeological Research Team (CART) and some of our more stalwart volunteers. Nonetheless we have plowed forward on both the Historic and Prehistoric sites. Furthermore, at the beginning of the month, the Friends of Fairfax County Archaeology and Cultural Resources (FoFA) sponsored an open house to help draw attention to our project. We estimate that as many as 100 people attended the December 4 event including members of the press and Chairman of the Fairfax County Board of Supervisors, Sharon Bulova.



Several features of note have been uncovered at the historic site. We placed some tests on a suspicious mound with architectural stone and brick, located south of the excavations by the road. Expecting to come down on a brick and stone architectural feature, instead we identified at least two posts, evidence of a post-in-ground structure. Nearer the road, two test units exposed a stone masonry foundation wall. As if this was not exciting enough, excavation into the interior revealed a second, interior stone masonry division.

Oddly, the interior division extends diagonally from the outer foundation wall, rather than being oriented squarely. Additional excavations will be necessary to properly categorize this structure. The historic crew will fan out to the southern and western reaches of the site. Volunteer help is essential.

Meanwhile, the prehistoric crew has also been out We began by testing the previously testing. recorded site boundaries. Our work shows that this site is even larger than expected. As a result, efforts have necessarily shifted back to transit work. We have spent the past couple days laying in loads of new test excavation locations on this ever expanding archaeological site. Excavations will resume shortly. This site is an incredibly rich and expansive resource capable of telling us a lot about the prehistory of Mason Neck.

The December 4<sup>th</sup> open house was a resounding success, due in large part to the efforts of our supporters and volunteers. As visitors streamed in, they were treated to a host of energetic volunteers in Datum Point

the field, exposing new finds and sharing their interests. FoFA prepared the excellent eats that included colonial appropriate sweets and hot mulled apple cider. Members of the Northern Virginia Chapter help our efforts by guiding the interested public through the site, informing them about opportunities, and introducing folks to the world of archaeology right here in their neck of the woods.

Moving forward, the historic crew will spend the next weeks in the same vicinity. We are placing more tests in locations considered likely to bear fruit. Units placed in this way have led to our most stunning discoveries. We will also continue working outward on this site, into what were some of the town back lots. We hope to learn more about the townspeople from the work along the road and more about folks often forgotten by history from excavations in the back. The prehistoric crew will continue trying to find the true boundaries of the site before moving into the core to better understand how large a site we are dealing with and then figure out what how the site was used and how that relates to the larger picture of Late Woodland prehistory.



We want to thank all the volunteers that have helped us on both the historic and prehistoric crew. The ASV has been the largest and most reliable source for volunteers, by far. We continue to need your assistance, so as always, when you want to come out and lend a hand, drop us a line at CART.volunteers@gmail.com; let us know if you are more historic or prehistorically inclined.
