

VETERAN'S DAY PRESENTATION:
THE ROLE OF
FORT MONTGOMERY AND THE
HUDSON HIGHLANDS
OF NEW YORK
DURING THE AMERICAN
REVOLUTION



In August 1775 the Continental Congress ordered immediate construction of fortifications on both sides of the Hudson River in the Hudson Highlands of New York. Fort Constitution was begun on what is now West Point. By March 1776 work was diverted to begin erecting Fort Montgomery about six miles downriver. Fort Montgomery, it is nearby õtwin, ö Fort Clinton, and Fort Constitution all were taken by British forces in early October 1777. Despite loss of those defensive works and thus the control of the entire Hudson Highlands, the battle played a significant role in why the British campaign to divide the Colonies failed.

With a focus on Fort Montgomery, this talk will summarize archeological investigations through the years and relay how important the Hudson Highlands were to defending the Colonies from before the first parapet was raised, up through and following the time when Benedict Arnold traitorously attempted to give up West Point.

Dana Linck is an archeologist with fifty years of field experience, including 27 years with the National Park Service, 11 with FEMA, and others with private companies. His first paycheck was for archeological fieldwork at Fort Montgomery in 1967, and pending USPS delivery, his next payment will be for work at the same site. Dana has a long history of work with a variety of Revolutionary War era sites in the Highlands region, including forts and redoubts, tent and hut encampments, and homesites. Now a Maryland resident, he intends to continue building that experience.

#### **CART**

#### Fairfax County Archaeological Research Team

As we get farther into the fall season the weather continues to improve for field archaeologists. There are less bugs this time of year and some of the denser foliage begins to die off giving much better sightlines through the parks. Field work at Mount Air was finished up earlier this month, there is always the possibility of returning but for now the team will focus on writing up the results from the past year of investigations.



This month CART has been taking time to focus on research and reporting on several different projects that have been completed over the past few months. Some of our team members have been visiting the Virginia Room and using other sources to further understand the histories of these parks as well as deed research and transcription to trace back the ownership of these sites. Our lab director and assistant lab director continue to work hard on cataloging and processing all of the artifacts brought in from these projects while also managing our databases.

Fairfax County Park Authority ArtiFACTS blog recently highlighted a cache of glass marbles uncovered by CART from our Ashgrove site excavated a few years ago.
