

Topic: This month's speaker is Colleen Betti, speaking on "Go Ahead and Erect the Building Themselves: The Archaeology of Three Black Schools in Gloucester County, Virginia"

Colleen Betti has over a decade of experience in the fields of archaeology and historic research in the mid-Atlantic region, particularly on seventeenth through twentieth century historic sites. She has had the opportunity to work on projects in Virginia, Maryland, and North Carolina.

Her work has been published in the Journal of African Diaspora Archaeology and Heritage, and she has presented numerous papers at the Society for Historical conference. Archaeology the Middle Atlantic Archaeological Conference, Southeastern Archaeological Conference, and the Archeological Society of Virginia conference. Ms. Betti currently serves on the board of the Woodville Rosenwald School Foundation.

# Artifacts From Harriet Tubman's House





Maryland Department of Transportation has uncovered numerous artifacts from the location of the former home where Harriet Tubman spent her teenage years. The site of the home of Ben Ross (Mrs. Tubman's father) in Dorchester County has become the focus of extensive work by MDOT archaeologists, who have put their <u>findings</u> online for all to see.

MDOT's <u>website</u> details the methods used to locate the Ross home and the history surrounding the land. The site features detailed, high-resolution images of artifacts and a detailed explanation of how the site was located. The reader is encouraged to visit the site and learn more about this fascinating topic.
